WHEREAS:-

- (1) Mr. James is seised in fee simple in possession of the property described in the First Schedule hereto free from incumbrances
- (2) Mr. & Mrs. Hodgkinson are seised in fee simple in possession of the property described in the Second Schedule hereto subject to the covenants and conditions hereinafter mentioned but otherwise free from incumbrances

- 2. MR. & MRS. HODGKINSON hereby jointly and severally covenant with Mr. James for the benefit of the adjoining or neighbouring property of Mr. James at Rudchester including the property hereby conveyed to him (and provided that no Purchaser for Value of the said property or any part thereof shall be entitled to enforce the benefit of this covenant unless it has been expressly assigned to such Purchaser) in manner set out in the Third Schedule hereto 3. IT IS HEREBY AGREED AND DECLARED that Clause 3 of a Conveyance dated the Fourth day of April One thousand nine hundred and sixty seven made between Mr. James of the one part and Mr. & Mrs. Hodgkinson of the other part shall henceforth be read and construed as if the expression "Part O.S. 2100 hereby conveyed" had referred to that part of O.S. 2100 that shall belong to Mr. & Mrs. Hodgkinson after the execution of these presents

 4. MR. & MRS. HODGKINSON declare that they are joint tenants in equity and that the Trustees for Sale of the property described in the First Schedule hereto shall have powers to deal with it equal to those of a sole beneficial owner but so that these extended powers shall be exercisable only during the period of eighty years from the date hereof

thereof and hereby undertakes for the safe custody thereof

- 6. IN consideration of the Conveyance hereinbefore made Mr. & Mrs. Hodgkinson as

 Trustees hereby convey unto Mr. James ALL THAT the property described in the Second

 Schedule hereto TO HOLD the same unto Mr. James in fee simple SUBJECT to the covenants and conditions contained in the said Conveyance dated the Fourth day of April One thousand nine hundred and sixty seven so far as the same are still subsisting and capable of taking effect and affect the property described in the Second Schedule hereto
- 7. MR. JAMES hereby covenants with Mr. & Mrs. Hodgkinson by way of indemnity only to observe and perform the covenants and conditions contained in the said Conveyance dated the Fourth day of April One thousand nine hundred and sixty seven so far as aforesaid and to indemnify Mr. & Mrs. Hodgkinson against any liability resulting from their breach or non-observance
- 8. MR. & MRS. HODGKINSON hereby acknowledge the right of Mr. James to production of the said Conveyance dated the Fourth day of April One thousand nine hundred and sixty seven and to the delivery of copies thereof and hereby undertake for the safe custody thereof IN WITNESS whereof the persons parties hereto have hereunto set their respective hands and seals the day and year first above written
